1. The total number of sections of the school from class I to X shall be restricted to 20. The optimum number of the students shall be restricted to 40 for a classrooms size of 500 sq ft and above. Further, increase of sections shall be subject to specific approval of the Board based on the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension. 

	accordance with established norms permitted vide Board's circular no. 12/2023 dated 24-03-2023 & 25/2023 dated 11-09-2023.
2	Regular Cubicles converted into CWSN toilets but its entrance and toilet are very narrow and entry of the wheelchair or walker is not possible inside the toilet. Thus, the school is required to construct the ramp and spacious CWSN toilet separately for Boys and Girls with handrails on both side of toilet seat (fixed and movable) where the arrangement of classes and practical (Labs) for the CWSN is made by the School as per circular no. 11/2024 dated 09.08.2024 and proper permanent signage (on the cubicle indicating the floor number) as per the guidelines issued by the Board and the provisions laid down in the RPwD Act 2016 within 03 months and submit compliance on SARAS Portal.
3	Lab stools (wooden) are provided in the computer lab which are not appropriate to work on computer. Other required facilities such as LMS, Webcam, interactive Board, projector and speakers are also not available in the lab. School shall upgrade the lab in the light of SoP issued by the Board within 03 months and submit compliance on SARAS portal.
4	Separate reading area for staff and ICT infrastructure is not installed in the library. School shall add collection of classics, autobiographies, biographies, travelogues, essays, fiction, poetry, drama, recreational and motivational materials. Dictionaries, encyclopedias, yearbooks, children's magazines, illustrations, maps and charts, other reference materials and install ICT infrastructure to cater the need of access digital/cloud reading material within 03 months and submit compliance on SARAS portal.
5	The school shall ensure the mandatory training of its teachers with CoE, CBSE, Chandigarh within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.


This order is being passed in due compliance of order dated 12.04.2023 passed in CWP no. 7238 of 2023 – Federation of Private Schools and Association of Punjab v. State of Punjab and others, by the Hon'ble High Court. The operational part of the order reads as under: -

"Keeping in view the above said facts and circumstances, the present petition is disposed of with a direction to the Secretary, Department of School Education to consider and decide the representation dated 12.01.2023 (Annexure P-11), in accordance with law within a period of six weeks from the date of receipt of the certified copy of the present order. While taking a decision, the judgment of the coordinate Bench of this Court passed in CWP no.12389 of 2021 titled as "Ameliorating India, NGO vs. State of Punjab and others" decided on 02.11.2021 (Annexure P-8) be also taken into consideration."

2.0 The Federation of Private Schools and Association of Punjab filed a Civil Writ Petition no. 7238 of 2023 before the Hon'ble Punjab and Haryana High Court with the prayer to issue permanent recognition orders to members of the petitioner Federation in terms of the Right of Children to Free and Compulsory Education Act, 2009, and further, to issue recognition orders without incorporating the word 'provisional'.
